Members indicated that they had looked into this option and one indicated UW Safety will do some training. It was unclear if the UW program only did training for UW staff or outside agencies as well. Stephanie and Susan will look into this as an option for a future meeting. Additionally, Seattle Opera may have a lead on an individual and another member recommended contacting King County Public Health. A suggestion was made to make part of the dues geared towards hiring a consultant to come and do/present on PPE training annually.

A SHERN member recommended the Red Cross Earthquake App (American Red Cross) that tracks and monitors earthquakes.
