- **Updates from the Chair (Jules)**
  - Jules discussed two meeting invitations she had recently received on behalf of SHERN, extending those to the group

- **Treasurer's report (Kristopher)**
  - Balances

  - Suggest inviting 4-Culture to upcoming meeting to discuss possible funding opportunities

- Supply Committee
  - No update, but ready to move forward with purchasing once banking systems are in place
- **Potential Joint Workshop with SHEPARD and the Pierce County Group (Sarah)**
  - Discussion of potential workshops in 2025 to be offered in partnership with SHEPARD, the Pierce County group and the Washington Museums Association. Details are still being finalized, including dates, costs, etc.
  - Sessions would be offered both in King County and in Eastern Washington.
- **Western Museums Association Conference Update**
  - Disaster Response Session (Stephanie M.) in Tucson
    - RC-WR panel presented on seasonal disasters, historical disasters, and general disaster preparation, through the lens of west coast institutions
    - Session ended with a group activity working through a fictional apocalypse and was well attended and received.
- **Updates from members**
  - Seattle Municipal Archives: has compiled resource list for nitrate negative disposal. Discussions of issues around cold storage freezers.
  - Henry: Contractor accidentally caused pest infestation. Discussion around response and how it happened.
  - Burke: Ongoing HVAC issues with subsequent repairs, which seem to be working. Ongoing ground leaks through shelving tracks. Unknown cause
  - Seattle Public Library: Ongoing HVAC issues in offsite storage due to proximity of a neighboring gym / sauna. Update on ransomware attack recovery. Update on digitization and rehousing related to the Paul Dorpat collection

- Museum of Flight: Welcome to a new staff member, Ollie, who brings the objects team up to three people. Update on the museum's new strategic plan which will likely include a collections move and new building construction.
- Diocese of Olympia: Erik recently participated in a leadership training course centered around disaster response and hosted by the Smithsonian.
